For the abovementioned considerations, I hereby release the Club, its members, governors, officers, and agents, as such, from any and all liability of any nature for injury or damage resulting from the action of any dog, and I expressly assume the risk of such damage or injury while on the premises.

I understand that this release will apply to any future DGOTC training class or activity I may attend, in addition to the specific one listed above, whether training be continuous or not.
